# The MASTER CLASS

This Master Class will focus on the approaches taken in the UK to address individual choice of preferences and wishes as the end of their life nears. The UK End of Life Care (EOLC) Strategy aims to provide choice, reduce hospital stays and avert admissions. Advance Care Planning is a key factor in the End of Life Care Strategy and the Master Class will give participants an opportunity to understand one of the tools being used, i.e. Preferred Priorities for Care

The key components of the UK EOLC strategy will be explained including the tools utilised (Preferred Priorities for Care, Gold Standards Framework and Liverpool Care Pathway) and the benefits that have been derived for individuals, their families and health and social care providers.

The Master Class will also provide an insight into the UK approach to individual choice, including the UK Mental Capacity Act, Advance Decisions to Refuse Treatment and Advance Care Planning. The UK approach has benefitted individuals from a wide range of conditions including renal failure, COPD, Motor Neurone Disease, Cancers as well as frailty and dementia.

By looking at the UK approach, participants will understand where the UK are coming from and how it might link to developments of ACp in NZ & Australia.



## About LES STOREY

Les Storey qualified in 1970 and spent over 14 years in clinical practice before moving into the fields of education and research. Since 1989 he has been involved both nationally and internationally in the development and implementation of competency based approaches within nursing and healthcare.

### His recent work includes:

- Leading the work to develop the Preferred Place of Care, (now Preferred Priorities for Care) an Advance Care Planning process for recording patient preferences about care at the end of life
- Mapping the competences needed by staff working in a range of care areas including:
  - ⇒ prison healthcare staff
  - ⇒ palliative care for community nurses & allied health professionals
  - ⇒ -assessing and managing dysphagia

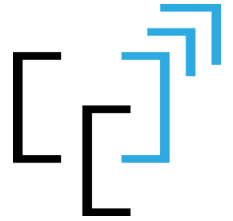
- Researching nursing in secure environments across the UK both within the Prison Service and secure mental health care
- Developing National Occupational Standards for the assessment and management of dysphagia
- Evaluating capacity and caseload management in substance misuse services

He is the National Lead for the National End of Life Care Initiative (Preferred Priorities for Care), Former RCN Council Member & Chair of the North West Board of the RCN and a Member of the National Council for Palliative Care Policy Group.

In 2000 he was conferred as a Fellow of the Royal College of Nursing for his work on competency based education, and in 2001 was awarded the Edith Cavell scholarship by the Florence Nightingale Foundation. In 2007 he was awarded Fellowship of the Higher Education Academy.
